

Procurement Notice: Invitation to Quote for Secure Transportation Services in Baghdad

2. Low-Profile Escort within Baghdad:

- Discreet transportation for staff traveling within Baghdad for official duties.
- Vehicles must be **low-profile** and designed to avoid drawing unnecessary attention.
- Routes should be pre-assessed for security risks.

3. International Zone Access:

- Drivers must possess the necessary **badges** to access the **International (Green) Zone** in Baghdad.
- Drivers will be responsible for escorting **staff who do not have badges** into the Green Zone as required.

Security Requirements:

- Vehicles must be well-maintained and equipped with necessary safety features.

- Drivers must be trained in secure transportation protocols and have experience in high-risk environments.
- The security company must have a proven track record of providing safe, secure, and reliable transportation services in Baghdad or similar high-risk areas.

Quotation Requirements:

- All quotes should be presented in **US dollars**.
- Provide a **daily rate** for the transportation services, including all associated costs (fuel, tolls, etc.).
- Outline any additional fees for specific services, such as airport transfers or special security arrangements.

 - Details of security measures implemented for transportation.
